TERMS AND CONDITIONS

1. Auction of the items (on scrap basis) mentioned below shall be conducted online at www.auctionindia.com on the dates & times mentioned against each item.
2. The intending tenderer should enclose a demand draft for Rs.100/- drawn in favour of the Secretary, Puducherry Housing Board, Puducherry payable at Puducherry towards the cost of the application fees(not refundable).Applications without Application Fees and EMD will not be entertained.
3. The intending tenderer should enclose Earnest Money Deposit for Rs.2,000/- (Rupees Two thousand only) in the form of demand draft in favour of "Secretary, Puducherry Housing Board, Puducherry" payable at Puducherry.
4. On remitting the prescribed cost of application fee and EMD, the tenderer shall obtain the Username and Password for participating in the auction.
5. It is responsibility of the applicant to safeguard the username and password. If the applicant happens to lose the username and password allotted to him/her, he/she may obtain a fresh one on remittance of the EMD once again.
6. The last date for remittance of EMD is 27.09.2017. Only those applicants who have remitted the EMD and received the userid/password before the stipulated date & time can participate in the auction.
7. The intending tenderer should quote the bid amount above the starting bid amount of Rs.20,000/-.
8. Each bid will be in multiples of Rs. 500.
9. The EMD of the unsuccessful tenderers, will be refunded immediately after the auction is over and EMD of the selected tenderer will be adjusted at the time of billing.
10. The successful bidder should pay the full amount within 2 days from the date of receipt of Board's Order of acceptance, failing which the quoted bid will be treated as cancelled and the EMD will be forfeited.
11. If the selected tenderer fails to remit the bid amount as stated in Sl. No. 10 above, the next highest responsive bidder will be considered at the discretion of the Chairman/Secretary , Puducherry Housing Board and the EMD will be forfeited immediately in respect of him.
12. The successful bidder should be present at the time of handing over of the items and sign all the relevant documents.
13. The Puducherry Housing Board will in no way be held responsible for the safe custody of the item once the auction is finalised.
14. No claim about the condition and value of the items will be admitted once the auction is confirmed.
15. e-auction charges will be collected @ 3.5% on the sale amount from the successful bidder.
16. The intending tenderer can inspect the above said items during office hours. It shall be the responsibility of the bidder to inspect and satisfy themselves about the items before submitting the bid.
17. The PHB is not bound to accept the highest offer and he has absolute right to accept or reject any or all offers or adjourn/postpone/cancel the e-auction without assigning any reasons.
18. In case any dispute arises, the decision of the Secretary, Puducherry Housing Board will be final.
19. TCS at 1% and GST @ 18% will be charged on the bid amount.
